

**MCAS IWAKUNI PRISONER ESCORT CLASS
NOMINATION & QUALIFICATION SCREENING**

Per references (a) and (b), and MCAS Iwakuni Pre-Trial Confinement Facility standards, service-members nominated to attend chaser escort training to serve as command prisoner escorts must meet the following requirements:

- Mature, emotionally stable, demonstrated leadership qualities, and able to handle emergencies
- No psychiatric disorders or history of alcohol abuse or in-service drug use
- No Courts-Martial convictions or Non-Judicial Punishment in the **past** 36 months and maintain a clear record during tour as an escort.
- No record of civil court convictions (except misdemeanor traffic violations)
- No obvious disabilities/disfigurements speech impediments that may lead to ridicule
- Within body fat standards, & passed service PFT/CFT, PRT
- No prior removal/revocation of escort status
- Not identified as a witness/victim in a prisoner's courts-martial related to the escort detail
- Not have failed in last two prior attempts to pass the escort proficiency test

Nominated personnel must attend a one-day 8 hour Brig Escort Class, pass a proficiency test, sign an *Escort Standards of Conduct* form, and receive an escort ID card (NAVPERS 1640/18). Certification is **valid for one year** from course completion date.

Military service members **will not** wear civilian attire to class. (Only Uniform-of-the-day is authorized). Attendees shall bring a military ID, pen and notepad. ATTENDEES ARRIVING AFTER 0830 **WILL NOT BE ACCEPTED**.

NOTE: 1. Per reference (c) Army/Marine Corps Military Police, Air Force Security Police, Navy Master-at-Arms, sworn law enforcement officers of the investigative services and formal NEC/MOS school-trained personnel **are exempt** from attending the class as long as they meet the screening criteria listed above.

2. New confinements and permanent releases **do not** require a certified chaser.
